**General Rules for Admission to Various Undergraduate Courses**

- The instructions related to the admissions given here are as per the Act, Ordinances, Rules & Regulations of the University.
- Candidates need to apply separately for each Undergraduate programme except for B.Sc. (Maths/Home Science/) and B.Sc. (Bio/Home Science).
- In various programmes, the number of seats for admission in University Campus and affiliated Government/ Self-financed Colleges through the Joint Entrance Test being conducted by the University is predetermined. **See Appendix 'A' for a detailed description.**
- **Admissions to Minority Colleges will be in accordance with Government Order No-2651 / Sattar-2-2003-16 I92I /2002 Dated 02 July, 2003.**
- **Reservation will be subject to the latest provisions of the Government (Only for University Campus and affiliated Government /Aided Colleges).**
- Order of Merit will be determined as follow -

If two or more candidates have secured equivalent marks/rank in the merit index, then the merit for admission will be determined as-



1. The candidate who has secured higher percentage of marks at 10+2 or equivalent examination will be given preference.
  2. If the marks secured in class 10+2 or equivalent examination are the same in such cases the older candidate will be given priority.
- As directed by the Hon'ble Supreme Court, action will be taken against the students who indulge in incidence like ragging during studentship.

Candidates belonging to Other Backward Classes are required to produce their latest Caste Certificate issued by the competent authority which clearly mentions that they do not fall under the Creamy Layer as per the State Government's latest provision.

**A. Comment:** No more than two of the above mentioned weightages shall be added together. No candidate shall be entitled to more than 4% weightage on the basis of any two points.

**Comment:** The benefit of this weightage will be given only for admission in the University campus and affiliated Government / Aided Colleges.

Only the certificate issued by the competent authority mentioned against the certificate in the table below will be valid, which will have to be submitted at the time of admission for verification.

**B. Weightage for LLB Three Year** - will be provided in the following manner: (i) 2 percent for students of Colleges affiliated to Deen Dayal Upadhyaya Gorakhpur University. (ii) 5 percent to the candidates who hold qualifying degree from University Campus for admission to Postgraduate and Law courses. (iii) 2 percent for female candidates. (iv) 2 percent for the students with 'B' or 'C' certificate in N.C.C. (v) 2 percent to the candidates who served 240 hours and took part in at least one special camp under the National Service Scheme. The weightage will be applicable only if the certificate is signed by the Vice Chancellor. (vi) 2 percent for Rovers and Rangers.

**COMMENT:** Not more than two of the above mentioned weightages shall be added together. No candidate shall be entitled to more than 7% weightage on the basis of any two points.

**Comment:** The benefit of this weightage will be given only for admission in the University campus and affiliated Government / Aided Colleges.

- For the dependents (husband / wife / son / daughter) of teaching and non-teaching staff of the University, **the maximum reservation is 50 seats (Supernumerary) of the total number of seats for admission in each Undergraduate and Post Graduate programmes.** Applicants in the category will have to produce the Dependent Certificate issued by the **Registrar** to the Coordinator's Office within the stipulated dates. Thereafter their application forms will be filled online by the Coordinator's Office. These admissions will be as per the reservation rules, availability of seats, and Subject Combinations and marks scored in the Joint Entrance Test. No dependent will be admitted to the University without appearing in the Entrance Test. This facility is permissible only for the University Campus.

### • **Maha Yogi Shri Guru Gorakshnath International Fellowship**

The main objective of the fellowship is to attract talented international students and to encourage them towards a global perspective of education. The 17 Fellowships per year will be awarded as per the following details:

#### **International students shall be given admission without entrance test.**

International Research students - 02 Fellowships @ Rs. 1,00,000/- per annum for three years.

International U.G./P.G. Students – 10 Fellowships @ Rs.80,000/- per year.

Travel and stay of Indian Research Students to work for short duration abroad – 05 Fellowships with:

- (a) Travel Grant at actual up to a maximum of Rs.1,00,000/-
- (b) Sustenance fund @ \$1000/- per month for a maximum duration of six months.
- (c) Contingency \$1000/- for 3 months stay and \$2000/- for full 6 month stay.

### • **Maha Yogi Shri Guru Gorakshnath Fellowship for Super Hundred Sportspersons**

#### **The selection procedure for this Fellowship will be as follows:**

The shortlisted candidates will have to go through a selection process of physical fitness test and specific sports skill/performance test to be conducted in front of competent committee.

- Physical Test
- Sport Specific Skill
- A write up on Maha Yogi Guru Gorakshnath
- Merit for admission will be made on the basis of this selection process and their last three year's achievements in sports.

#### **The Games/sports offered for this Fellowship will be as follows:**

Athletics, Archery, Hockey, Football, Judo, Taekwondo, Basketball, Badminton, Tennis, Cricket, Volleyball, Kho-Kho, Kabaddi and Wrestling.

The selected candidates are required to fulfill minimum 85% of ground attendance. The period of participation in sports tournaments/ coaching camps will be treated as attendance. The attendance in academic classes will be as per University norms.

The selected students will be annually evaluated through their yearly sports performance in Inter-University/ State/ National/ International level competitions and testing procedure as decided by the committee constituted by the Vice-Chancellor.

- In the Undergraduate programmes of the University campus, seats are earmarked for the candidates who have participated in the State / National / International sports. Admission under this will be given as per the criteria set through the competent committee nominated by the Vice Chancellor. **Candidates have to necessarily indicate it at the place specified in the application form.** If the admission of a candidate with such option is not done on merit basis, then the person will be issued information for admission in sports quota through proper channel. Applicants shall have to appear with a State / National /International level Sports Certificate. Under the sports quota, admission will be possible relative to the faculty-wise allocated seats. This facility is available for the University Campus only.

### **Eligibility for Under Graduate Programmes**

Students appearing for Intermediate or its equivalent examination in the year 2023 can also appear in the Undergraduate Entrance Test, however, at the time of admission, they have to produce the passing certificate / mark sheet of the qualifying examination.

Details of qualification for various programmes based on 10+2 or equivalent Test.

1. **Bachelor of Arts.:** Candidates who have passed the 10+2 or equivalent examination.
2. **Bachelor of Science (Maths group):** Candidates who have passed the 10+2 or equivalent examination in the Science stream (Maths group).
3. **Bachelor of Science (Bio Group):** Candidates who have passed the 10+2 or equivalent examination in Science stream (Biology Stream).
4. **Bachelor of Agriculture:** Candidates who have passed the 10+2 in Agriculture or equivalent examination in Science (Mathematics or Biology) stream.
5. **Bachelor of Science (Home Science):** Candidates who have passed the 10+2 or equivalent examination in Science (Mathematics or Biology) stream.
6. **Bachelor of Commerce:** Candidates who have passed the 10+2 or equivalent examination.
7. **Bachelor of Business Administration:** Candidates who have passed 10+2 or equivalent examination with a minimum of 40% marks.
8. **Bachelor of Computer Application:** Candidates who have passed 10+2 or equivalent examination with a minimum of 40% marks.
9. **B.Sc. Physiotherapy (BPT):** Candidates who have passed the 10+2 or equivalent examination in Science (Mathematics or Biology group) with a minimum 45% marks for GEN/OBC and a minimum 40% for SC/ST.

10. **B.Sc. Medical Laboratory Technology (M.L.T):** Candidates who have passed the 10+2 or equivalent examination Science (Mathematics or Biology group) with a minimum 45% marks for GEN/OBC and a minimum 40% for SC/ST.

11. **Bachelor of Engineering (B. Tech.):** Candidates who have passed the 10+2 or equivalent examination in the Science stream (Maths group).

12. **BA. LL.B (Integrated Five Year Program):** Candidates who have passed the 10+2 or equivalent examination.

13. **BAJMC Three Year Course:** Those candidates would be eligible for admission in BJ (Bachelor of Journalism) who have passed intermediate or equivalent examination with 45% or more marks from any recognized Board.

14. **Bachelor of Law- (LL.B.) Three Years course:**

In order to get admission in three years L.L.B. course, applicants of the General, O.B.C. and S.C., S.T. categories will have to achieve minimum 45%, 42% and 40% respectively in their final year examination (U.G./P.G.) required for eligibility according to the rules of the Bar Council of India. Admission process will be conducted according to the latest available criteria of Bar Council of India.

LL.B. (Three Years) is a full time regular course. Students cannot take admission in any other course (Degree/Diploma/Research etc.) of this or any other University/Institution. Such candidates who are government employees or students of any other course will not be considered eligible for this course.

**Admission will be granted on the basis of the rank in the merit list together with the achievement of the minimum marks in Entrance Examination which is 35% for General candidates, 25% for O.B.C., 20% for S.C. and 15% for the S.T. category applicants.**

15. **Bachelor of Physical education-**

Please read the directions related to entrance examination and eligibility provided in the concerned brochure available on the website.

## **Admission Procedure**

After the Entrance Test, candidates need not fill choice of institution for B.A, B.Sc. (Biology), B.Sc. (Mathematics), B.Com and B. Tech, as admissions to these programmes is restricted to the University campus only.

**Candidates need not fill the choice of institutions for B.Sc. (M.L.T), B.Sc. (Physiotherapy) as these programmes are available in only one affiliated College.**

For admission to B.B.A, B.C.A, B. Sc. (Agriculture) and BA. LL.B programmes, according to availability in the Colleges, applicants will print the hard copy of their application for the chosen programme and thereafter make the maximum possible options online (choice filling) according to the opted programme.

Applicants can fill the choice of the Colleges in order to preference within three days of the declaration of the results of Entrance Test. The choice of the preference of Colleges has to be done separately for different programmes.

Candidates found eligible shall be given provisional admission based on their choice of programme, Entrance Test score and permissible weightage. Admission shall be given strictly according to the order of merit and the availability of seats.

Keeping the reservation rules in mind, the admission process shall be conducted in the following manner

- University Campus
- Government and Aided Colleges
- Self-funded Colleges

The list of students allotted to the University/Colleges will be made available on the website in accordance with the respective programmes.

Admission to the Undergraduate programmes available in the University campus shall be done through **online counselling** in the following manner –

Applicants selected in the list for the University campus shall appear for the counselling and verification of their documents at the time and place decided by the University. The information regarding this shall be available on <https://ddugu.ac.in>.

After the verification of the documents, the subject combinations allotted to the candidates on the basis of merit shall be uploaded on the University website.

Note:

- Only those candidates can opt for Home Science who have studied Home Science at the 10+2 or have qualified Intermediate Test in the Science stream.
- Only those candidates can opt for Geography who have studied Geography at the 10+2 or have qualified Intermediate Test in the Science or Agriculture stream.
- It shall be compulsory to opt for Mathematics along with Statistics.
- **Every subject has of fixed number of seats. Change of subject shall not be entertained after the admission.**

**Note:** Industrial Chemistry and Industrial Microbiology subjects are being run under the self-finance scheme.

- (iii) Candidates will have to deposit their prescribed fees online (through Net Banking/Debit card /Credit Card etc.) within the prescribed time and date and ensure admission. In case the selected candidate fails to deposit his/her fees by the due date, the seat shall be considered vacant and offered to other candidates in order of merit.
- (A) Admission will be done on the basis of the list according to the syllabus of the State / Aided College (under the relevant rules). On the basis of the issued list, the candidate will have to go to the respective College with all the original certificates and complete the admission process by the due date.
- (B) For admission in Self-Finance Colleges the admission will be done on the basis of the declared merit list. The candidates must appear in the allotted College along with all the original certificates and complete the admission process. At the time of admission, the candidate has to present all the original certificates along with

their self-attested photo copies (Aadhaar card, mark sheet, Caste Certificate, Over-representation certificate, Disability/Ex-serviceman/dependent of freedom fighter/ Kashmir displaced/Kashmiri Pandits residing in Kashmir valley/Ward of Kashmiri Hindu family/Kargil martyrs, Divyang certificate, Transfer Certificate/Character Certificate provided by the Principal of the institution last attended, etc.) to the Admission Committee. Candidates who have passed from other boards / institutions (like CBSE, ICSE and other boards) besides Uttar Pradesh Secondary Education Council will also have to bring a Migration Certificate

1. It will be mandatory to register the name of the selected candidates after submission of required fee in the concerned Faculty Office/College; otherwise their admission is liable to be cancelled.
2. Original Certificates regarding details of any Category, Sub category or Weightage filled in by the candidates in the application form shall have to be produced at the time of admission. In case of the candidate not being able to produce the original certificates, he/she shall be deprived of the benefit and the merit list is liable to be changed.
3. The candidate will have to declare to the effect that there is no criminal suit against her/him and in future if any FIR is registered, her/his admission shall be liable to be cancelled.
4. The University reserves the right to deny admission to any candidate without assigning any reason.
5. **The candidate will have to compulsorily produce their admit cards at the time of admission and so they are advised to keep them safe.**
6. Entrance test dates for various programmes shall be available on the University website.
7. All the forms / records related to the Entrance Test will be preserved only for six months from the date of completion of the Entrance Test.
8. Candidates who have passed the qualifying Test before the year 2023 will have to produce **an affidavit certified by the notary at the time of counseling for clarification of the above mentioned interval.**
9. The candidate shall be considered a regular student of the University/College from the date of payment of his/her fees and registration at the concerned department.
10. Admission related rules are as per the University Act, Statutes & Ordinances. The Admission Committee may cancel the admission of any candidate without assigning any reason.
11. In case of discrepancy in relation to admission, decision of the Admission Committee shall prevail.
12. Once admitted and having appeared/failed in the examination of a particular class in the University/College, a student shall not be readmitted in the same class but can appear as an Ex-student in the Test.
13. There will be no admission in any class of the University on the basis of transfer from any College or other University.

## COMMON ELIGIBILITY FOR ADMISSION IN POST GRADUATE PROGRAMMES

1. Applicants are suggested to thoroughly read and understand the eligibility criteria and other requirements as given in the Brochure.
2. For admission in M.A./M.Sc./M.Sc. (Ag.)/ M.Com, only those candidates are eligible who have either passed qualifying examination or are appearing in Qualifying examination in the year 2023.
3. Students appearing in Graduation/eligibility examinations or its equivalent examination in the year 2023 can also appear in the Entrance examination for LL.M. and Postgraduate courses but, at the time of admission, they will have to produce the pass Certificate/Mark sheet of the qualifying examination.
4. Those candidates who have passed their qualifying examination before 2023 have to give clarification for the period of gap in the form of affidavit/satisfactory document certified by the public notary at the time of taking admission.
5. No Entrance Test will be conducted in the concerned course/ programmes if the number of applications is less than the number of available seats.
6. **It is compulsory for every candidate to acquire minimum 40% marks in qualifying examination in order to secure admission in Postgraduate courses. Candidates of SC/ST category are exempted from this rule**

### PROGRAMME-SPECIFIC ELIGIBILITY

#### **(i). M.A. /M.Sc. Programmes:**

M.A. Hindi, English, Sanskrit, Urdu, Sociology, Political Science, Philosophy, History, Ancient History Archaeology and Culture, Defense and Strategic Studies, Visual Art, Performing Art, Education, Mathematics, Geography and Psychology:

The candidate must have passed B.A. /B.Sc. from any recognized University. They must have passed their graduation third year examination in the concerned subject, also. Admission in Post graduation (Arts and Science) first year would be given only in any one of the subjects opted in graduation (third year).

#### **(ii). M.A. in Economics:**

The candidates must have passed B.A. / B.Sc. from recognized University and in Graduation (third year) he/she must have opted and passed with Economics/ Mathematics/ Statistics as a subject.

#### **(iii). M.A. in Continuing Education and Extension Work:**

Graduation in any stream with minimum 40% marks or equivalent grade from any recognised university.

#### **(iv). M. Sc Programmes:**

M.Sc. in Physics, Chemistry, Botany, Zoology, Mathematics, Defense and Strategic Studies: The candidate must have passed BA/ B.Sc. from any recognized University, and he/she must also have passed the third year examination in the concerned subject. Admission in Post graduation (Science) first year would be given only in any one of the subjects opted in graduation (third year).

**(v). M. Sc/MA in Statistics:**

The candidates must have passed B.A. / B.Sc. from recognized University and in Graduation (third year) they must have opted & passed either with Statistics or with Mathematics, as a subject.

**(vi). M. Com:**

The candidate must have passed B.Com from any recognized University.

**(vii). M.B.A.**

All candidates who have passed graduation degree with minimum 40% marks from any recognized University are eligible to appear in entrance test for MBA.

**(viii). M.Sc. (Environmental Science):**

(a) Those candidates would be eligible who have passed B.Sc. (life Science)/ BSc (Biology) from any recognized University. In Graduation (Third Year), the candidate must have opted for Botany/Zoology/Industrial Microbiology/Microbiology/Biotechnology.

(b) Those candidates would be eligible who possess the eligibility mentioned in (a) above and also fulfill the following:

i. Candidates who are sponsored by the government institutions or public corporations or private institutions for admission in this programme.

ii. Foreign students/non-resident Indians should have permission from the University for Admission in the above mentioned programme

**(ix). M.Sc. (Electronics):**

The candidate must have passed B.Sc. examination from any recognized University and have opted for either Physics or Electronics in the third year of Graduation.

**(x). M.Sc. (Biotechnology):**

The candidate must have passed B.Sc. examination in Science stream (Maths or Zoology group) from recognized University, and have scored minimum 55% (for Unreserved/OBC Categories) or 50% (for SC/ST Categories) marks.

**(xi). M.Sc. (Home Science):**

The candidate must have passed B.Sc. (Home Science) three year/ four year programme from a recognized University.

**(xii). M.Sc. (Microbiology):**

The candidate must have passed B.Sc. examination from a recognized University in Science stream (Mathematics or Biology group) and have scored minimum 55% marks (for Unreserved/OBC Category) and 45% marks (for SC/ST category) Candidates. In Graduation (Third Year), the candidate must have opted for Botany/Zoology/Industrial Microbiology/ Microbiology/Biotechnology.



**(xiii). M.Sc. (Agriculture):**

The candidate must have passed B.Sc. (Ag.) from any recognized University.

**(xiv). M. Sc. Agriculture in Campus:**

The candidate must have passed B.Sc. (Ag.) from any recognized University.

Ten percent seats of M.Sc.(Ag) programmes shall be available for candidates nominated by the I.C.A.R. on the basis of combined admission test conducted by ICAR for B.Sc.(Ag) and Master' Degree Programme on SUPERNUMERARY basis.

**(xv). LL. M. First Year:**

- i. 55% marks in LL.B. (B.A.LL.B. or equivalent) is necessary in order to get admission in LL.M. first year for the applicants of General and O.B.C. categories whereas this rule will not be effective in the case of S.C. & S.T. applicants.
- ii. Students who have appeared in LL.B. (B.A.LL.B. or equivalent) final semester examination can also take part in LL.M. Entrance Examination on the condition that they will have to produce certificate of their minimum educational qualification at the time of admission otherwise their admission will not be allowed.
- iii. Only those applicants would be eligible for appearing in the entrance examination of LL.M. who have passed their LL.B. (B.A.LL.B. or equivalent) programme [or who have appeared in the final semester examination of their LL.B. (B.A.LL.B. or equivalent) programme] from a recognized university or institution. Final semester students of LL.B. (B.A.LL.B. or equivalent) programme of the session 2022-2023 can also fill the application form and appear in the Entrance Examination on the condition that they will have to produce pass certificate/mark sheet of the qualifying examination at the time of admission.
- iv. The medium of teaching-learning is Hindi, generally. However, basic knowledge of English language is essential for this purpose.
- v. All those applicants, who have applied for improvement/back paper in their undergraduate [LL.B. (B.A.LL.B. or equivalent)] examination and have qualified for admission, will have to produce their latest mark sheet before the Admission Committee. If the results of these examinations are not declared by that time, such applicants will not be allowed to get admission.
- vi. Applicants who have passed their qualifying examination before 2023 will have to produce an affidavit for the clarification of the gap at the time of admission. Admission committee will permit such applicants for admission only when its members are fully satisfied with the reasons cited in the affidavit.
- vii. Admission will be granted on the basis of the rank in the merit list together with the achievement of the minimum marks in Entrance Examination which is 35% for General candidates, 25% for O.B.C., 20% for S.C. and 15% for the S.T. category applicants.
- viii. At the time of admission each applicant will have to submit a Character Certificate issued by the institution last attended. This rule will also be applicable for the students of D.D.U. Gorakhpur University, Gorakhpur.
- ix. If any applicant fails to present himself/herself with all his/her original documents before the Admission Committee at the appointed time on the prescribed date, his/her admission will stand cancelled.
- x. General rules of the University regarding *Reservation* and *Weightage* will apply.
- xi. The University reserves the right to deny admission to any student without citing the reason or to make desired circumstantial changes in the rules of the admission.

**(xvi). M. Ed:**

1. Minimum aggregated 50% marks or equivalent grade is required in any one of the following examinations for the applicants:

NOTE: This minimum percentage shall be relaxed by 5% in case of OBC, SC, ST, and DIVYANG (Physical Handicapped) applicants.

3. Candidates appearing in qualifying examination are not allowed to appear in M.Ed. Admission Test.
4. Unlimited gap is allowed between qualifying examinations and attempt to M.Ed.

**Eligibility for Admission in M.Ed. Programme**

1. Only those candidates are eligible to appear in M. Ed. entrance examination-2023 who has achieved aggregated (marks of theory + practical) minimum 50% marks in B.Ed. or equivalent degree from any recognized university or equivalent institute. OBC/ SC/ ST and Physically Handicapped (Divyang) candidates are required to achieve aggregated (marks of theory + practical) minimum 45% marks in B.Ed. or equivalent degree. It shall be binding for the candidates to produce the proof of minimum eligibility otherwise; candidate shall not be authorized to get admission.
2. Only those candidates can appear in M. Ed. entrance examination-2023 who has qualified B.Ed. or equivalent examinations. Candidates appearing in qualifying examination are not allowed to appear in M.Ed. Admission Test.

NOTE: Again, candidates should start the process of filling up the application only after confirming their eligibility. Not-eligible candidates, in any case, shall not be allowed to appear in the test. Such admission shall stand cancelled in case they get admission in the programme.

**WEIGHTAGE in M.Ed. Programme**

Weightage marks to the candidates of following categories shall be given only after they produce required certificate/s to the admission committee issued from competent authority. **Total weightage marks shall not exceed to 07 percent (28) of total marks of Entrance Examination, in any case.**

4. Only permanent domiciles of Uttar Pradesh are eligible to avail the reservation under SC/ ST, OBC and EWS categories. Reservation certificates must be on the proper format as decided by government and issued by competent authority. These certificates issued in the name of father of the candidate are valid.

5. It is compulsory for the OBC candidates that their caste certificates must clearly state about their not being covered under the creamy layer. This certificate shall be accepted only if it is issued as per the caste of father of the candidate.

6. Admissions under Divyang category shall be done only on recommendation of the Medical Committee constituted by the University. Divyang certificate issued by Chief Medical Officer must clearly state that the candidate is neither stammering nor is unfit for becoming a teacher due to some problem with his/ her ears and eyes.

7. Relation of the candidate with honourable Freedom Fighter must be clearly stated in the certificates of dependents of freedom fighters. (Only those certificates of Dependents of Freedom Fighters shall be acceptable which clearly state Memo and Reference Number of the certificate).

8. Reservation in admission to the Divyang candidates, dependents of freedom fighters and Defence personals and their wards shall proportionately be given under their respective general or reserved categories.

9. In case of non-availability of the candidates of Scheduled Tribe Category the seats, thus remained vacant, shall be filled up by the candidates of Scheduled Caste category.

10. The seats under Horizontal Reservation for which suitable candidates are not available shall be filled up by general candidates of concerned caste category.

11. Benefits of the reservation shall not be allowed in case of candidate's inability to produce proper certificate for reservation or in case of producing such certificate issued by not competent authority or in case of producing incomplete certificate/s. Such candidates shall be considered for admission in (Open Category) General Category as per the rules of merit.

12. As per notification order of Government of Uttar Pradesh, Higher Education Section-2, Number: 1191/ 70-2-2010 (58) /79 date: 11 June, 2020 there is no provision of reservation in the admissions in self-financed colleges.

1. Other State candidates shall be given admission maximum up to 5% of total open seats. All other rules and regulations for admission in M.Ed. shall be applicable as decided earlier. Other state candidates are eligible for admission only on basis of their merit for general/ open category seats.

2. Only those candidates shall be considered as Other State candidates who are domiciles of other than Uttar Pradesh and have completed their eligibility or equivalent degree from the state other than Uttar Pradesh.

**(xvii). PG Diploma in Disaster and National Security Management (PGDNSM):**

Candidates who have passed B.A./ B.Sc./ B.Com./ L.L.B. from recognized University or equivalent examination from any foreign University/Institute would be eligible. Those candidates would be given preference who have opted for Defense and Strategic Studies/Economics/ Geography/ Psychology/ International relations/Law/any one subject from Science stream in Graduation.

**GENERAL RULES AND REGULATIONS FOR ENTRANCE/ADMISSION**

1. Go through all the instructions given in the admission brochure carefully.
2. Before submitting/ mailing the duly filled-up application form, go through all the points contained in the form.
3. The merit list declared by the University shall be final and binding.
4. If any document/declaration submitted by the candidate is found to be false/ forged at any stage, his or her admission shall be cancelled and he/she may be liable for prosecution under law.
5. The selection to the program will be provisional until the candidate furnishes the required documents and testimonials, including the final results of the qualifying examination at the time of admission.
6. Involvement of candidate in any form of criminal activities debar the candidate from seeking admission in any program of the university. Concealment of information on this account will lead to cancellation of admission, if detected subsequently.
7. If the University is not satisfied with the character, past behaviour or antecedents of a candidate, it may refuse to admit him/her to any program of study in the University.
8. It is advisable that students seeking admission in the University to see the infrastructural facilities such as classrooms, laboratories, library and hostels etc.
9. University will not be responsible for any kind of error in filling up the application forms by the candidates. Any change in application form will not be accepted latter on.
10. The registration fee will not be refunded in any circumstances.
11. Candidates should regularly check university website for updates.
12. Candidates, themselves, must download their Admit Card, counseling letter etc from the university website.
13. Candidates need to apply for admission to each program separately. Application in one program will not be transferred to other program, in any case.
14. All the form/records related to the entrance examinations/tests will be preserved only for six months from the date of the date of completion of entrance examinations/tests.
15. Last date for online application may be extended by decision of the University.
